## ***Career Opportunity for the post of CHIEF EXECUTIVE OFFICER (CEO)***

### **Areas of Responsibility**

- The CEO will report to the Board of Directors and will work closely with the Board in the development of strategic plan to advance the company's mission and objectives as well as to promote transparency and enhance revenue.
- The candidate must demonstrate leadership skills, possess management and team building experience, and have excellent communications and interpersonal skills.
- The candidate must possess the ability to work as a team player to nurture an environment of opportunity for maximum creativeness and sense of accomplishment and the utilization of administrative practices, which will assure an efficient operating organization.

### **Qualifications & Experience**

- A Bachelor or Master degree in Engineering, or Masters degree in Business/Management from a recognized University, or Fellow Member or ICAP/ICMAP.
- Minimum fifteen (15) years relevant experience, out of which 5 years must be at a senior management level in the power distribution sector.
- The candidate must be thoroughly conversant with the legal and regulatory framework in which GEPCO is operating.

### **Remuneration & Age**

- The assignment will be on contract-basis for a period of three (03) years, extendable on the basis of satisfactory performance. A market based competitive package will be offered commensurate with the qualification and experience of the candidate.
- The candidate should not be more than sixty-two (62) years old on the closing date of application.
